There is a 'Speed Limiter' fitted to this vehicle, set at 56mph. By LAW you are NOT permitted to drive on Motorways in the 3rd or outer subsequent lanes.

It is a legal requirement that you fill in the logbook inside the minibus. If you do not, you will be driving it illegally and will be stopped from using the bus. Mini Bus Breakdown details and a copy of the Insurance Certificate are inside the blue folder. This form must be returned with the key and monies, IMMEDIATELY you have completed the journey. The Mini Bus SHOULD be parked in the same bay (left far side of the main hall, 3 places away from the hall). This is opposite a garden wall where the key safe & post box is located. The key MUST be placed in the key safe & DON'T forget to 'roll the numbers' once you have placed the key inside to lock the safe. Deposit this journey form & monies in the letter box along side of the safe.
